

Gettysburg Outlets Contest
OFFICIAL RULES

NO PURCHASE NECESSARY.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED.

1. ELIGIBILITY: The **Gettysburg Outlets** (“Promotion”) is open to legal residents of the 50 United States (including the District of Columbia) who are 18 years of age or older at date of entry. The **Wyndham Gettysburg Hotel**, Interstate Management Company, L.L.C. and each of their respective parent companies, affiliates, subsidiaries and related companies (collectively, “Sponsor”), and each of their respective officers, directors, employees, agents and members of the immediate family and persons living in the same household of each are ineligible. No purchase is necessary to enter this Promotion. By participating, entrant agrees to abide by these Official Rules and the decisions of Sponsor, which are final and binding in all respects.
