

Community Partner Contest: McDonalds 10 Free Sandwiches and \$10 Gift Card
OFFICIAL RULES

1. ELIGIBILITY: The **Gateway Gettysburg Community Partner Contest: McDonalds 10 Free Sandwiches (limited to Big Mac, Quarter Pounder with Cheese, Chicken McNuggets (6), Filet-O-Fish, Any Breakfast McMuffin Sandwich or Biscuit Sandwich from the following Pennsylvania locations: Gettysburg, Hanover, Limekiln Rd, Littlestown or New Oxford) and \$10 McDonalds Gift Card** (“Promotion”) is open to legal residents of the 50 United States (including the District of Columbia) who are 18 years of age or older at date of entry.
